**OR706-V Oregon Estate Transfer Tax Payment Voucher and Instructions**

Use this voucher to send the following payments for Form OR706, *Oregon Estate Transfer Tax Return, 150-104-001*, and Form OR706-A, *Oregon Additional Estate Transfer Tax Return, 150-104-007*:

- **Tax due when you file your original return.** Check the "Original OR706 return" box. Include the voucher with your check in the same envelope as your return.
- **Tax due by the original return due date.** If you're applying for an extension of time to file your return, check the "Extension" box. Include the voucher with your check.
- **Prepayment of tax if you are making a payment before the original due date of your return.** Check the "Prepayment" box. Include the voucher with your check.
- **Tax due with an amended return.** Check the "Amended OR706 return" box. Include the voucher with your check in the same envelope as your amended return.

**Form OR706-A:**

**Tax due with Form OR706-A, *Oregon Additional Estate Transfer Tax Return.*** Check "Form OR706-A return (148)" box. Don't fill in the date of death. Insert your name, SSN, and mailing address in the place of the decedent's name, SSN, and mailing address and cross out the words "decedent" and "executor."

**Helpful tips:**

- **Payment type:** Check the box that identifies the type of payment you are sending.
- **BIN:** Fill in the BIN (Oregon business identification number) if known.

Please use blue or black ink. Do not use gel pens or red ink.

**Make your check payable to:** Oregon Department of Revenue. To ensure proper credit to your account, write the following on your check:

- **For Form OR706:** the decedent's name, the year of death, and "Form OR706."
- **For Form OR706-A:** your name, year of property disposition, and "Form OR706-A."

**Note:** Don't use this voucher as an extension to file. Use IRS Form 4768, *Application for Extension of Time To File a Return and/or Pay U.S. Estate (and Generation-Skipping Transfer) Taxes*, and mail to us by the original due date of your Form OR706 or Form OR706-A. Attach a copy of the extension to your return.
